The Stephenson Family of Kirby Township of Northampton County, North Carolina

There seems to be at least three distinct families of Stephensons that settled in Northampton County. The oldest branch seemed to have settled in an area of Bertie County that became Kirby Township in Northampton County in 1741 when Northampton was created from Bertie County. After 1800, a family of Stephensons located in the Pleasant Hill area of the County and another branch located in the Seaboard area. Possibly a fourth branch settled before 1800 near the Roanoke River on Bridgers Creek which is between Rich Square in Northampton County and Scotland Neck in Halifax County. The Bridgers Creek Stephensons sold their land in 1787 and there is no evidence that their descendants live in Northampton County.

All three/four branches *may* have a common ancestor in a John Stephenson who was born in the 1640/50s and resided in the Upper Parish of Isle of Wight, Va (Smithfield, Va). According to a friend, Becky Dozier, John was probably born in England or Scotland and came to Virginia as a young man, however she states that she has no proof of his origin. John married Elizabeth Edwards, a daughter of Charles and Mary Edwards of Isle Wight County. John died abt 1727/28 and in his will named his wife, Elizabeth, and children John, Abraham, Thomas, Charles, George, Mary and William Stephenson.

Abraham Stephenson, son of John Stephenson and Elizabeth Edwards of Isle of Wight County / Southampton County, Va, is believed to have moved to Bertie County/Northampton County around 1739. It is this Abraham Stephenson that I believe is the forebearer of the Stephenson family that settled in the Kirby Creek Township of Northampton County.

To further confuse one's understanding of the Stephenson family, Augustus Stephenson, a descendant of the Seaboard Stephensons, married Virginia Britt who lived between Severn and Murfreesboro. In his 1859 will, Elijah Britt gave his daughter, Virginia Britt Stephenson, a farm located about a mile from Pendleton toward Margaretsville. Augustus and Virginia Stephenson lived on the farm near Pendleton and had ten children, two of which married into the Kirby Township Stephensons. Ada Agustus, my grandmother, married Charlie Thomas Woodard the son of Starkey Woodard and Mary Jane Stephenson. Robert married Mollie Sikes, daughter of W. P. Sikes and Cordelia Stephenson. Descendants of both the Kirby Township Stephensons and Seaboard Stephensons families live in the Conway/Severn/Pendleton area of the County today.

The current spelling of Stephenson seemed to have prevailed over other variations. In many of the early public records you find the spelling to be Stephenson, Stevenson, Stephens, and Stevens and in some instances there are different spellings in the same document.

Becky Dozier and Lou King have been a great help to me in this effort and have given me many of their notes and citations. I owe much to Lou King who has abstracted many of the early Stephenson deeds and wills. And to Becky Dozier, who is currently writing a book on Northampton County families. Becky cites as some of her sources; Blanche Adams Chapman-Wills and Administrations of Isle of Wight Co, Va.; James Mark Valsame-Nimrod and Amanda Stephenson of Pleasant Grove Township, Johnson County, NC; John Brodie-Seventeenth Century Isle of Wight, Va and various deed and will books of Isle of Wight, Va. Jean Stephenson Stinson, who lives in Texas, has graciously provided me with information on the Stephensons who migrated to Arkansas.

The following notes are incomplete and may contain errors. It is my desire that anyone who might read these notes and finds any material error of fact or assumption that they would advise me of my error so that I might make a correction. The notes are incomplete and I am currently making additions and corrections. If you, as a reader, can help me to complete my Kirby Township Stephenson Family history, I would be greatly appreciative. I know there are many private sources such as family bibles and other private writings that would add to my effort.

First: I will that all my just debts be paid.

Item. I give and bequeath unto my Grandson William Stephenson five shillings to him and his heirs forever.

Item. I give and bequeath unto my Daughter Mary Jones five shillings to her and her heirs forever.

Item. I give and bequeath unto my Daughter Elizabeth McCone five shillings to her and her heirs forever.

Item. I give and bequeath unto my Daughter Martha Vick forty pounds current money of the State to her and her heirs forever.

Item. I give and bequeath unto my Daughter Mildred Smith forty pounds current money of the State to her and her heirs forever.

Item. I give and bequeath unto my Daughter Tabitha Stephenson forty pounds current money of the State to her and her heirs forever.

Item. I give and bequeath unto my Daughter Lucity Clifton forty pounds current money of the State to her and her heirs forever.

Item. I lend the labour of all my negroes and the lent of all the other part of my estate to my wife as long as she lives a widow.

Item. I give and bequeath unto my Son Abraham Stephenson all the remainder part of my estate of whatsoever kind it be unto him and his Heirs forever.

Note 1. David Newsom Stephenson family Document. "According to the records Abraham, the great Grandfather, and Arter, the grandfather, were both buried near the family home in a private cemetery. That location, which is probably under cultivation at the present time of 1974, was on the road between Hedspeth Crossroads (between Conway and Pendleton but nearer Conway) and Galathia. At one time it was known as the W. P. Sykes' place---probably inherited by Delia, sister of Mack (D. N.). This land was last owned by Viola and Carrie (daughters of Mollie Stephenson and Carrie Harris. Present Ownership not known."

Note 2. Gilbert Stephenson notes: not dated. "My great-great grandfather. Lived at W. P. Sykes place where Mr. Wheeler lives. Owned about 1,000 acres, and 20 slaves, Farmer. Was in the Revoluntary War. Buried at home near the house. 200 yards north of the house. Now under Cultivation."
