The records do not indicate the company or regiment of the North Carolina Line in which Abraham served. It was likely he served in the 3rd, 7th or 10th Regiment, which were organized in whole or in part with companies from the Halifax District, which included Northampton County. Items 1 and 3 above indicate that Abraham's account at the settlement at Warrenton was received by William Faircloth, who was a lieutenant in the 10th Regiment. See North Carolina Troops in the Continental Line, A Register of Officers, with Dates of Commissions, Made up under Direction of the Secretary of State, W. L. Saunders, from Records in His Office, October, 1884 ("Saunders List"). However, this does not necessarily indicate that Abraham served in this regiment.

The 3rd Regiment was organized in 1776 and initially assigned to the Southern Department. On July 8, 1777, it was assigned to the North Carolina Brigade of the Main Army. Having been reduced to a cadre at Valley Forge, it was relieved from the Main Army on June 1, 1778. In July 1778, the 3rd was reorganized at Halifax and assigned to the Highlands Department, then to the Middle Department and then to the Southern Department. It was reorganized again on November 5, 1779, at Halifax and assigned to the Southern Department. On May 12, 1780, the 3rd Regiment was captured by the British Army at Charleston, South Carolina. The 3rd Regiment was involved in the engagements at Charleston, 1775-76; Florida; the defense of Philadelphia; the Philadelphia-Monmouth campaign; and Charleston in 1780

when it was captured.

The 7th Regiment was organized in the spring of 1777 at Halifax. In 1777, it was assigned to the North Carolina Brigade, an element of the Main Army. It was disbanded on June 1, 1778, at Valley Forge. The 7th Regiment participated in the defense of Philadelphia and the Philadelphia-Monmouth campaign.

The 10th Regiment was authorized as an additional North Carolina regiment known as Sheppard's Additional Continental Regiment. It was organized in April--June 1777 to include men from northeastern North Carolina and was adopted into the Main Army. It was disbanded on June 1, 1778, at Valley Forge.

Notes for JOHN STEPHENSON:

John's age is estimated based on the assumption that he was at least 21 years old at the date of the 1821 deed from his father Abraham. See deed 8 under Deeds in the Notes for Abraham.

John also was an executor named in the will of his brother Arthur (see Will in the Notes for Arthur (d. 1823)), acted as guardian for the minor children of his brother Jenkins (see Estate Records in the Notes for Jenkins) and was trustee under a deed of trust for David, a son of Arthur (d. 1823) (see deeds 3 and 4 under Deeds in the Notes for David).

Northampton County court minutes indicate that John was a constable of the county in the 1820's.

Notes for CHARLES STEPHENSON:

The birth date of Charles is estimated based on the assumption that he was at least 18 years old when he witnessed the 1776 deed from his father Abraham Jr. to John Fly. See deed 1 under Deeds in the Notes for Abraham Jr.

It appears that Charles had two wives, Dorcas and Mary, as well as daughters named Dorcas and Mary. The 1788 will of Abraham Jr. names a daughter-in-law Dorcas Stevenson but no son other than Charles. His will also names a grandaughter Polly Stevenson but not a grandaughter Dorcas or Mary. Item 2 of the estate records of Charles described below indicates that his wife at the time of his death was Mary. The estate records described below also indicate that Charles had a daughter Mary (item 3) as well as daughters Polly and Dorcas (item 1). Therefore, it is assumed that Charles' first wife was named Dorcas and that they had a daughter Polly before August 21, 1788, the date of Abraham Jr.'s will, and a second daughter named Dorcas some time after that date. It is further assumed that Charles' first wife Dorcas died some time prior to Charles' death in 1793, that Charles married second wife Mary and that they had conceived a daughter named Mary before Charles' death in 1793. To further complicate things, both Charles' daughters Polly and Mary seem to have married a Bryant.

See Deeds and Land Grants in Notes for Arthur Sr.]

- 1. It is not clear whether Charles died intestate or left a will, but no will has been found in the records. John Boon was appointed administrator of the estate. See bond dated June 4, 1793. Other documents state that Hudson Thompson acted as Charles' executor. See bond dated December 2, 1793. John Boon was initially appointed guardian for Charles' minor daughters Polly and Dorcas. See bonds dated September 2, 1793.
- 2. Petition of Charles' widow Mary for allotment of dower in Charles' land adjoining Joseph Boon, James Jenkins and others states that Charles died some time in the month of January 1793. However, Mary was found not entitled to dower for reasons unspecified. Northampton County Court Records, Minutes 1792-1792, 1813-1821. C.071.3001, page 193.
- 3. In the 1807 June Term of the court, Benjamin Bryant and his wife Mary filed a petition alleging that John Boykin, who had been appointed guardian for Charles' daughter Mary in 1796, had misappropriated her property by taking all but a small portion of the funds from the rent of real estate and for the hire of slaves for his own use.
- 4. On February 10, 1808, five commissioners appointed by the court divided 543 acres of land in Charles' estate between his heirs Polly Bryant and Dorcas Barnes. The plat in this document shows the property adjoining the Meherrin River, Cow Island gut, the long branch, the old country line, Robert Cobb, James Hosey, Lazarus Cook, William Boon, John Fly and Samuel Deberry. This land appears to be the same land described in deed 6 under Deeds and Land Grants in Notes for Abraham Sr. [The records do not indicate whether Charles' estate included other real estate, although item 3 above may suggest it did, or why Charles' daughter Mary or his son John, if alive, did not receive a share of the land alloted to Polly and Dorcas.]

William Stevenson to Elijah and John Stevenson dated March 31, 1826, deed to sons Elijah and John, \$100 and "the further consideration of the maintenance and support of me and my wife Penelope during our joint and several lives as well as for the natural love and affection which I have and bear unto my sons", for (a) the remaining land William purchased from Presley Pritchard [see deed 7] adjoining the long branch, lick branch and cross branch, and (b) one slave, Jacob, one yoke of oxen, one bay mare, four goats, one sow and seven pigs, six sheep, six geese, three cows, three calves, one ????, four beds and furniture, five sitting chairs, one walnut and one pine table, one cupboard, three iron pots, one Dutch oven, one cart and wheels and "all the remainder and residue of my plantation utensils and household and

kitchin furniture"; signed by William Stevenson [with a mark]; witnessed by Hardy Cobb; followed by bond of \$1,000 securing the obligation of Elijah and John to maintain and support William and Penelope, signed by Elijah and John Stevenson [no mark indicated]. NH DB 22: 454.

- 10. Joshua and Frances Vick (of Southampton Co. Va.) to William Stephenson dated April 11, 1831, \$125 for 68 acres adjoining A. Johnson, Benjamin Boon and the branch; witnessed by Kinchen Stephenson, N. Stephenson and John Stephenson [no mark indicated]. NH DB
- 11. John D. Amis, Clerk and Master in Equity, to William Stephenson dated [month and day blank], 1832, \$680.25 for 225 acres sold upon the petition of Benjamin H. Pritchard and other heirs at law of Joshua Pritchard, adjoining William Stephenson, Simon Wood, Henry Phillips and Benjamin H. Pritchard, subject to the dower rights of Mrs. Dorothy Harrison, the widow of Joshua Pritchard; witnessed by William H. Hardee. NH DB 25:460.

[The age of the oldest male in the 1820 and 1830 censuses is inconsistent with the age of the oldest male in the 1786 NH census and the 1800 Federal census, suggesting that the William in those later censuses was a different William. In addition, the 1830 Federal census for Elijah Stephenson (see Census Records under notes for Elijah) includes a white male and a white female, both age 60-69, in Elijah's household. They are probably William and his wife Penelope. See also deed 9 above.]

Tax Records:

In the 19th century, Northampton County taxpayers were listed by districts, corresponding to the militia districts. A map prepared about 1860 shows the location of these districts. Most Stephensons were in District 4, north of the road through Martin's Crossroads (present Conway) and to the west of District 7; District 5, south of the road through Martin's Crossroads and west of District 8; District 6, north of District 7 and to the Virginia border; District 7, south of the road through Martin's Crossroads and including the head of Patty's Delight near where the land grants of Arthur (d. 1792) were located; and District 12, in the northeast corner of the county adjoining the Meherrin River. Jesse, son of Arthur (d. 1823) also owned land in District 8, north of the road through Martin's Crossroads and south of Corduroy Swamp and Kirby Creek where some of the land owned by Arthur Sr. was located, and Jesse's brother Abraham appears also to have owned land in District 11, east of District 8 and to the border with Hertford County. The road dividing Districts 4 and 5 and Districts 7 and 8, which is shown as Bennet's road on the map, was probably located about where present Route 158 through Conway is now located.

In some cases it appears that information was incorrectly entered or omitted in the tax lists. Land values stated for tax purposes do not necessarily represent the fair market value of the land.

It is assumed that the William Sr. in the following tax lists was William, the son of Arthur Jr.

- **14.** ARTHUR⁵ STEPHENSON (ABRAHAM⁴, ARTHUR STEPHENSON³ SR., ABRAHAM STEPHENSON², JOHN¹ STEPHENSON) was born Bef. 1780, and died 1823 in Northampton County, North Carolina. He married (1) PENELOPE NEWSOM. He married (2) CHERRY DAVIS March 04, 1816, daughter of ARTHUR DAVIS. She was born 1793.

Notes for ARTHUR STEPHENSON:

Arthur's birth date is estimated based on the assumption that he was at least 21 years old when he appeared as the head of a household in the 1800 Federal census. See Census Records below.

According to research notes of Gilbert T. Stephenson (date unknown), Arthur lived "where B. J. Ricks lives now" (once known as the W. P. Sykes' place) near his father Abraham. The notes state that this property was probably inherited by Delia, the sister of David Newsom Stephenson, and last owned by Viola Stephenson and Carrie Harris, daughters of Mollie Sykes. The notes also state that Arthur was buried with his father Abraham in a private cemetery on the road between Hedgspeth Crossroads (between Conway and Pendleton but nearer Conway) and Galatia. According to the notes, the location of this cemetery was probably under cultivation at the time (1974).

The notes also state that Arthur's children David, Jenny, Becky and Winborne were never married.

- 4. Charles Stevenson to Arthur Stevenson [no relationship stated] dated January 28, 1817, \$635 for 135 acres on Coyroy Swamp adjoining Benjamin Boon, Benjamin Clifton and others; witnessed by [illegible] Johnson, John J. Stevenson and Thomas Martin. NH DB 18:148.
- 5. Arthur Stevenson to John Darden dated February 10, 1819 (signed August 25, 1820), \$108 for the dowry land laid off for the widow of Elias Darden; witnessed by John Stevenson. NH DB 20:434.
- 6. Arthur Stevenson to David Stevenson dated August 15, 1821, deed of gift to son David for 135 acres on Coyroy Swamp being the land called "Martin's place" adjoining Benjamin Clifton, Benjamin Boon, Charles Stevenson and others; witnessed by John and Charles Stevenson. NH DB 21:12.
- 7. Arthur Stevenson to David Stevenson dated August 15, 1821, deed of gift to son David of two slaves, Daniel and Martha; witnessed by Charles J. Stevenson and J. W. [?] Stevenson; proved in court by John Stevenson. NH DB 21:12.

Will dated January 17, 1823 (proved , 1823) (NH WB :]:

"In the name of God amen, I Arthur Stevenson of Northampton County and State of North Carolina being at this time of a disposing mind and memory thanks be to God for it therefore calling to mind the mortality of my body knowing that it is appointed for all flesh once to die do make this my last will and testament in the following manner and form First I give the following negroes to wit. Mike, Ephraim, Nancy, Rose, Dorcas, Tilda, Zilphia, Hasty, Cooper to my children namely, Winbourn, Jesse, Jinny, Abraham, Betsy, Rebecca Stevensons to be equally divided amongst them and their heirs forever also the whole of my land that I have in possession I give to be equally divided between my three sons Winbourn, Jesse and Abraham Stevensons after my death to them and their heirs forever--I give to my daughter Polly Futrell all the property that I gave her which she has in possession--I give to my son David Stevenson all the property that I gave him which he has in possession-I give the ballance [sic] of my property after paying all my just debts to be equally divided between my children namely, Winbourn, Jesse, Jinny, Betsy, Rebecca, Abraham, Littleberry, Tabitha and Pennylope Stevensons to them and their heirs forever--I also lend unto my beloved wife Cherry Stevenson one third of my lands, and one negro woman named Aggy during her widowhood--and at her marriage or death the said negro woman Aggy is to be equally divided amongst Jenny, Winbourn, Jesse, Betsey, Rebecca and Abraham Stevensons to them and their heirs forever--I do make and ordain my son David Stevenson and John Stevenson Exors to this my last well

and testament given under my hand and seal this 17th day of January--1823--

Witness: [illegible] Johnson Nathan Britten" Arthur Stevenson

Estate Records:

- 1. Legal proceedings were brought by Arthur's widow Cherry in the county court to challenge the validity of Arthur's will. A transcript of the proceedings in the 1823 March Term of the court states that a jury that included William Stevenson found that the document purporting to be Arthur's will was not his last will and testament. In a proceeding brought by the executors in the Superior Court of Northampton County, a different jury found that the purported will was Arthur's last will and testament. The will was admitted to probate. [Presumably, Cherry was unhappy with the bequests to her and her three children by Arthur, Littleberry, Tabitha and Penelope, compared to the bequests to Arthur's other children.]
- 2. Cherry then petitioned the county court 1823 June Term for her rights of dower stating that she was dissatisfied with the provision made for her in Arthur's will. On August 18, 1823, a jury consisting of John Martin, William Maddry, Jesse Darden, Elias Powell, Drury Nelson, James Daughtery, William Oliver, William Manson, John Gardner, John Futrell, Willie Suiter and Benjamin Boon awarded Cherry a portion of Arthur's land containing 58-2/3 acres adjoining Elias Powell and Benjamin Boon.
- 3. David Stevenson was appointed guardian for Arthur's son Winbourn, a minor. See bond dated June 3, 1823.
- 4. James Martin was appointed administrator for the purpose of conducting inventories and sales of property in the estate. See bond dated March 4, 1823.
- 5. Estate inventories and accountings of estate sales show the estate included, among other property, various farm implements, livestock including 20 sheep, 60 hogs, 2 horses, 10 head of cattle, vegetables including corn, potatoes and peas, cotton, lumber, a grind stone, bacon, beef, lard, a clock, a rug, a buffet, glasses, 3 books, tables, chairs, 4 beds and furniture, pots, earthenware, utensils, 3 packs of cards, a loom, a cubbard, a saddle, soap grease, a cradle, a trumpet, a cart and wheels, cider, 5 quarts of brandy and numerous other items. The estate also included 9 slaves in addition to Aggy.

Persons who bought property at estate sales included Arthur Davis, David Stephenson, James Martin, Absalom Jenkins, Charles Stephenson, Winborn Stephenson, Noah Futrell, Cherry Stephenson, Zaccheus Martin, Jesse Stephenson, James Daughtery, John Stephenson, Amos Parker, Drury Nelson, Buxton Allen and others.

6. Winbourn (through David his guardian), Jesse and Abraham petitioned the county court for a division of the land that Arthur's will provided was to be equally divided among them. On November 27, 1826, arbitrators consisting of Zaccheus Martin, Noah Odom, Willie Lewter, Jesse Darden and James Daughtery allotted the 170 acres of land adjoining Benjamin Boon's land into three tracts of 58-2/3 acres each.

- 7. In 1822, shortly before Arthur's death, Etheldred Martin (apparently the son of Etheldred Martin whose daughter Rhoda later married Arthur's son Jesse) commenced a slander suit in county court against Arthur claiming damages of \$500. [What Arthur allegedly said to slander Etheldred could not be determined from the available records.] A court transcript states that a jury reached a verdict in favor of the plaintiff, but awarded only 38 shillings in damages and assessed costs of the suit of \$21.36 against the plaintiff. The plaintiff appealed the verdict to the Superior Court; the records do not show the outcome of the appeal but there is no evidence that it was successful. Arthur's brother Benjamin separately sued Etheldred Martin for trespass vi et armis [The nature of the trespass does not appear in the records, but it was probably for some alleged injury to person or property.] Benjamin lost the case, apparently because the statute of limitations had expired.
- 8. Other litigation. The estate was also involved in other litigation, both as plaintiff and defendant:
- (a) Wright Allen obtained a judgment against the estate for debts of \$750 and interest plus costs of the suit.
 - (b) The estate sued Buxton Allen and James Daughtery for debts of \$224.
- (c) John Fly sued the estate and obtained an execution of judgment against the lands held by the estate for \$7.50 with interest plus \$2.80 costs. [Interestingly, Zaccheus Martin, a friend of Arthur's family, was the sitting court justice.]
 - (d) The estate obtained a judgment of \$254.63 including costs against Josiah Parker.
