Information as to the place of Jenkins' marriage is based on research notes of Gilbert T. Stephenson (date unknown); not independently verified. These notes state that Jenkins lived where Conway now is.

As indicated by the estate records, Jenkins was an educated man who appears to have studied law. See the list of items in his estate, which included a book of justice (item 2). Minutes of the Northampton County Court of Common Pleas and Quarter Sessions show that Jenkins was a justice of that court at the time of his death.

### Estate Records:

A report of the sale of estate property dated September 20, 1815, shows Martha, Arthur, Charles, John and Benjamin Stevenson, and several members of the Jenkins family, among

others, purchased items, which included a book of justice, a book of arithmetic, a hymn book, a bible, a woman's saddle, a brandy barrel, silver-plated spoons, a shot gun and a man's saddle.

3. At the 1815 Spring Term of the Court of Common Pleas and Quarter Sessions, Jenkins' widow, Martha, petitioned for her dower rights to a portion of 170 acres of land, adjoining Benjamin Stevenson, Etheldred Martin, Thomas Martin and others included in Jenkins estate, and requested that Winborn Odom be appointed to determine a proper division of the land between Martha and Jenkins' five minor children (under the age of 21), Sally, Burket, Charity, Matilda and Deberry [sic--other records show his name was Littleberry] for whom a guardian had not been appointed. The petition stated that Jenkins died in March 1815.

On November 17, 1815, a jury that included Zaccheus Martin, Arthur Davis, Nathan Britten, John Martin, Etheldred Martin and others awarded Martha one-third of the land, her tract adjoining Randolph Odom, Etheldred Martin and the road.

- 4. John Stephenson [probably Jenkins' brother] was appointed guardian for Jenkins' minor children (under the age of 21), Sally, Burkett, Charity, Matilda and Littleberry, who were still minors in 1825. See bond dated March 10, 1825, signed by J. W. Stevenson, Wright Allen and James Daughtry. Burket, Charity and Matilda were still minors in 1827. See item 6 below.
- 5. "In the name of God amen. I Benjamin Stephenson of the County of Northampton and State of North Carolina, being of sound mind and disposing memory, but considering the uncertainty of my earthly existence, do make and declare this my last will and testament in

manner and form following, that is to say:

First that my executor hereinafter named shall provide for my body a decent burial suitable to the wishes of my relations and friends and pay all necessary funeral expenses together with my just debts, howsoever and to whomsoever owing out of the moneys that may first come into his hands as a part of my estate.

Item1st I give and bequeath to my son Thomas B. Stephenson the sum of five dollars in money to be paid by my executor, to have and to hold in fee simple forever, and no more.

Item 2nd I give and bequeath to my four daughters, Mary A, Edith, Emeline Stephenson, and Patience Newsom, my two tracts of land, one tract known as the Everett place west of where I now live, and the other lying on Poticasi Creek containing fifty acres more or less to be equally divided between the four above mentkioned Mary A, Edith, Emeline and Patience to have and to hold to them their heirs in fee simple forever.

Item 3rd I give and bequeath to my three daughters Mary A, Eadith [sic] and Emeline Stephenson all my stock of horses, cattle, hogs, and sheep, of every description to be equally divided and all of my household and kitchen furniture of every description to be equally divided between my three daughters Mary A, Eadith and Emeline Stephenson to have and to hold to them their heirs in fee simple forever.

Item the 4th I give and bequeath to my four daughters Mary A. Stephenson, Eadith Stephenson, Emeline Stephenson and Patience Newsom all of my crop now growing of every description to be equally divided among them, and all of my provisions now on hand, to be equally divided between the last mentioned four, to have and to hold to them their heirs in fee simple forever.

Item 5th I give and bequeath to Mrs. Lavinia A. Davis the sum of twenty-five dollars in money to be paid by my executor, to have and to hold to her her heirs in fee simple forever.

Item 6th I give and bequeath to my grand children, William B. Ricks, Benjamin Stephenson, Samuel C. Stephenson and Sarah L. Stephenson and Elizabeth Stephenson two dollars each to have and to hold to them their heirs in fee simple forever.

Item 7th My will and desire is that all the residue of my estate if any, after taking out the devises and legacies above mentioned, shall be equally divided between my three daughters Mary A. Stephenson, Edith Stephenson, and Emeline Stephenson to have and to hold to them their heirs in fee simple forever.

In witness whereof I the said Benjamin Stephenson do hereunto set my hand and seal this the 5th day of July A.D. 1873.

A record documenting that Charles was a son of Abraham (d. Abt. 1823) has not been found. This information, other than the records described below and the first name of Charles' wife, Priscilla Newsom, was taken from research notes of Gilbert Stephenson (date unknown); not been independently verified. According to the notes, Charles lived in Hertford County near Ahoskie. In addition, a Charles Stephenson appears at estate sales recorded in the estate records of Jenkins and Arthur Stephenson, as does John Stephenson, a brother of Jenkins and Arthur. Charles and John Stephenson also appear as witnesses to deeds involving Arthur. These facts strongly suggest that he was a close relative, and probably the brother, of Jenkins and Arthur. See Notes for Jenkins and Notes for Arthur.

I Charles Stevens doth lend unto my dear wife Priscilla Stevens all of my property after paying my debts as long as she lives my widow and if she marries the property which I have lent to her then remains no longer hers but must be divided equal among all my lawful heirs and if she remain my widow until death it must be also divided as above written.

JESSE<sup>6</sup> STEPHENSON (ARTHUR<sup>5</sup>, ABRAHAM<sup>4</sup>, ARTHUR STEPHENSON<sup>3</sup> SR., ABRAHAM STEPHENSON<sup>2</sup>, JOHN<sup>1</sup> STEPHENSON) was born 1804 in Northampton County, North Carolina, and died 1854 in Northampton County, North Carolina. He married RHODA MARTIN

December 05, 1831, daughter of ETHELDRED MARTIN and MARTHA UNKNOWN. She was born 1817.

- 1. Etheldred Odom to Jesse Stephenson dated February 10, 1833, \$[illegible] for Odom's right, title and interest in a piece of land [acreage not specified] formerly belonging to Etheldred Martin and one slave, Jinny; witnessed by [illegible] Martin and Noah Odom. NH DB 26:142.
- 2. James Martin to Jesse Stephenson dated June 25, 1833, \$[illegible] for Martin's divided interest in 4 slaves, [first two names illegible], Malon and Sammy, that had belonged to the estate of his father Etheldred Martin; witnessed by A. Powell. NH DB 26:141.
- 3. Martha Martin to Jesse Stephenson dated [torn off], 1833, \$[torn off] for the land left to her during her first widowhood [acreage not specified] and [description of adjoining land torn off].

Hill, Henry White and others, and (b) the second tract of 102 acres on the south side of the road to Murfreesboro and touching the former tract adjoining Howell Francis, Henry White and others; witnessed by Henderson Martin and Danny Deloach. William Britt to Jesse Stephenson dated February 4, 1848, \$880 for 350 acres on Kirby Creek extending on the creek from Ramsay's mill tail to the Meherrin River adjoining Lucy Peebles and Uriah Vaughan, of which about 80 acres was bought from Foreman and others and 270 acres formerly belonged to Crawford Tyner; witnessed by William Smith and Alexander Britt. NH DB 32:349.

## Estate Records:

1. Jesse died intestate. His widow Rhoda was initially appointed administrator of the estate. See bond dated December 4, 1854, signed by Rhoda Stephenson [with a mark], David Stephenson [with a mark], Abram Stephenson and Henry White [with a mark]. [The Abram who signed the bond must have been Jesse's son Etheldred J. Abraham. Jesse's brother

Abraham had died prior to this date in 1854.]

- 2. In the 1854 December Term of the Court of Common Pleas and Quarter Sessions, Rhoda petitioned for her dower rights in the "house tract" adjoining James W. Hill, Henry White and others and in the "Meherrin tract", and named Jesse's sons Etheldred J. A. Stephenson and Joseph [Lorenzo J. W.] Stephenson as minors without a guardian. It appears that an allotment of land to Rhoda did not occur until 1859 (see items 4 and 5 below).
- 3. Also in the 1854 December Term, Rhoda petitioned the court for one year's support for her and her family and for an allotment to Rhoda of one feather bed and furniture and one wheel and pair of cards as her property. On January 5, 1855, Rhoda was awarded 5,200 pounds of pork, 175 barrels of corn, 15,000 pounds of fodder, 50 bushels of seed peas, 10 bushels of salt, one bed and furniture, one spinning wheel, one pair of cards, one cow and calf, one sow and pigs, 150 pounds of picked cotton, 250 pounds of brown sugar, 75 pounds of coffee, 10 gallons of molasses and 4 barrels of flour.
- 4. In the 1858 December Term of the Northampton County court, Howell Francis, to whom Rhoda was then married, and Rhoda petitioned the court for a division and allotment of slaves, who numbered 25 or 26, in Jesse's estate, one-third to Howell Francis in right of his wife and one-third each to E. J. A. Stephenson and L. J. W. Stephenson, L. J. W. being a minor without a guardian. Howell Francis and Rhoda also petitioned for a division and allotment of land between them and E. J. A. and L. J. W. that included 700 acres adjoining Wade H. Garris and 300 acres adjoining James B. Barnes.
- 5. On July 17, 1859, a jury that included Augustus Stephenson awarded 210 acres to Howell Francis in right of his wife Rhoda, representing one-third of the total value of the land in Jesse's estate. The award included a plat of this tract, which appears to include the "house tract" described in deed 4 above. The tract awarded included the dwelling house and out houses and was bounded by the road leading from Genomi Park's to Providence Meeting House [probably present county road 1360], the Murfreesboro road [probably present county road 1351] and James Garris.
- 6. The records include notes from Thomas Bolton and M. W. Smallwood for \$137 for the hire of a slave, Samuel, for the year 1859 and \$106 for the hire of a male slave [name not specified] for the year 1859, such slaves "to be furnished with usual clothing a hat and blanket and [are] to work on no public work".
